- **Diving shall be done in pairs and during Day Time only.**
- **All divers must be fast to a lifeline and no free diving permitted inside harbors**
- **No fishing/dumping activities while diving in progress**
- **Alpha flag is displayed where can best be seen by vessels and personnel operating with the vicinity of the operation.**
- **Port control to be notified before each diving operation.**
- **Personnel with an extra diving set and lifesaving appliances be present at the sight to assist the diver in case of an emergency.**
- **Work boat at waterside and listening watch on VHF channel 12/16**
